GM AMMONS PRESENTS INFORMATION ON THE FISHING PIER. WE HAVE THE ORIGINAL BID FROM TREVOR ON REPLACEMENT OF PIER FOR \$42,000.00. WE REQUESTED BIDS FROM OTHER FIRMS. TWO DIFFERENT SCOPES OF WORK. ONE IS TO REPAIR THE WALKWAY OF 47FT AND TO REPLACE THE LOOSE PILINGS. TREVOR ONLY TO DO 10FT AS A BANDAIDE WITH NO GUARANTEE. DYNASTY REMODELING TO DO REPAIR TO INCLUDE THE DECK AND 94 FT OF HAINDARAIL AND REPLACING 2X12 BEAMS AND FLOOR JOICE AT A REPAIR COST OF \$8,465, ANY LOOSE PILINGS WOULD BE \$365 ADDITIONAL. A COMPLETE REPALCEMENT WOULD BE \$37,500. INCLUDING ALL MATERIALS THAT ARE PRESSURE TREATED AND ALL SCREWS BOLTS WOULD BE STAINLESS STEEL. AS MOST OF YOU ARE AWARE WE DID A FORECLOSURE, OUR ATTORNEY HANDLED THIS BY DOING A PRE-EMPT FORECLOSURE, WHICH ALLOWS THE PROPERTY OWNER TO RECOVER PRIOR TO GOING TO COURT. THE PARTICULAR PROPERTY OWNER WAS SEVERAL YEARS BEHIND ON DUES AND REFUSED TO PAY THEM AND REFUSED TO SIGN A CONTRACT. AFTER THE PROPERTY OWNER WAS SERVED, 5 DAYS LATER HE CAME IN WITH THE BALANCE DUE OF ALMOST \$6,000 INCLUDING LEGAL FEES. WE HAD ANOTHER PROPERTY THAT WE HAD WON A JUDGMENT ON, THE OWNER HAD A RENTAL PROPERTY THAT WAS NOT ADJACENT TO HIS HOME, WE ASKED THE COURT FOR A WRIT OF EXECUTION ON THAT PROPERTY AND THE OWNER TRIED TO GIVE THE PROPERTY TO ONE OF HIS RELATIVES AND WAS ADVISED THAT IT WOULD STILL GO UP FOR SALE ON THE COURT HOUSE STEPS. THIS OWNER DID FINALLY APPEAR TO CLEAR THE DEBT, WHICH WAS ABOUT \$6,000. ALSO, I DON'T KNOW IF YOU NOTICED, BUT UP AND DOWN CHEYENNE, THE MOTOR HOMES ARE GONE. WE HAD STARTED LEGAL ACTION AGAINST THAT PROPERTY OWNER AGAIN AND SHE SOLD THE PROPERTY AND THE NEW OWNER REMOVED THE MOTOR HOMES AND CLEARED THE DEBT OF \$5,000. OUR STEPS ARE WORKING. WE ARE MOVING FORWARD WITH SOME MORE CASES, ONE IN PARTICULAR IS A \$8,000 DEBT. WE HAVE FOUND A GOOD ATTORNEY THAT IS MAKING IT WORK FOR US.

NEW BUSINESS:

VP GUINN CALLS UPON JOE TO PRESENT INFORMATION ON THE MOWERS. AT THE START OF THE SEASON I TOLD THE BOD THAT I WOULD TRACK THE LABOR & FUEL COSTS TO SEE WHERE WE ARE AT. I OBSERVED THIS FROM OUTSIDE FOR A COUPLE OF YEARS AND LAST YEAR WE HAVE WATCHED THE PROGRAM VERY CLOSELY. WITH FUEL COSTS AS THEY ARE, WE SHOULD NOT BE IN THE MOWING BUSINESS. THERE ARE SEVERAL GOOD LAWN MOWING BUSINESSES OUT HERE AND THEY HAVE ADVANTAGES THAT WE DON'T HAVE. THEY DON'T HAVE TO COVER SOME OF THE EXPENSES THAT WE HAVE TO COVER FOR OUR EMPLOYEES, SOCIAL SECURITY, INSURANCE, TAXES AND OTHER BENEFITS FOR OUR EMPLOYEES. I'M LUCKY TO BRING SOMEONE IN AT \$13.50 PER HOUR AND MOVE THEM UP TO \$15.00 PER HOUR IF THEY WORK OUT. AT \$15.00 THAT EMPLOYEE IS COSTING IS COSTING US \$21.00. YOU HAVE TO TO FIGURE IN SICK TIME, SOCIAL SECURTLY, ETC. WE TRY TO KEEP THE MOWING CHARGES REASONABLE BY CHARGING A MONTHLY CHARGE, NO MATTER HOW MANY TIMES WE MOW. IF WE WERE TO STAY IN THE MOWING BUSINES NEXT YEAR, WE WOULD HAVE TO CHARGE A MINIMUM OF \$50.00 PER LOT, PER MOW AND THAT IS FOR A STANDARD LOT, IT GOES UP FOR LARGER LOTS, MORE WEED EATING. WE ARE CURRENTLY IN NEED TO REPLACE MOWERS. MAINTENANCE IS HAVING TO REBUILD DECKS. I AM RECOMMENDING TO THE BOARD THAT WE KEEP TWO MOWERS AND ONLY MOW COMMON AREAS AND VIOLATIONS. WE CAN CUT THE LABOR AND GET BETTER COLLECTIONS LO ON THE VIOLATIONS THAT WE DO. WE ARE CURRENTLY \$15,000 IN THE RED WITH THE MOWING PROGRAM. WE WILL FINISH THIS YEAR AND NOTIFY EVERYONE THAT WE WILL NOT BE CONTINUING THE PROGRAM NEXT YEAR. I WOULD ASK THE BOD FOR THEIR DECISION. VP GUINN ASKS THE BOD FOR A MOTION.
