THE STATEMENT IS AS FOLLOWS: "WHEN HV OF FORK ASSOCIATION OFFICERS AND/OR DIRECTORS ARE LEGALLY CHALLENGED WE MUST ABIDE BY THE LEGAL PROCESS. IN OTHER WORDS, OUR BOARD MEMBER FIDUCIARY RESPONSIBILITY LEAVES US WITH NO OPTION BUT TO SEE THE ISSUES ARE HANDLED THROUGH THE COURT SYSTEM TO PROVE TO ALL MEMBERS THEIR ASSOCIATION AND THEIR INDIVIDUAL INTERESTS ARE BEING LEGALL PROTECTED. THEREFORE, I NOW MAKE A MOTION WE RESOLVE ALL LEGAL CHALLENGES THROUGH THE COURT." DIRECTOR DALEY MAKES THE MOTION TO ALLOW THE COURTS TO HANDLE THE LEGAL ISSUE, DIRECTOR LOLLAR SECONDED THE MOTION, PRESIDENT ALLEN CALLS FOR ALL IN FAVOR TO SIGNIFY BY SAYING AYE, DIRECTOR MARLOW, DIRECTOR DALEY AND DIRECTOR LOLLAR SAID AYE, DIRECTOR ALVAREZ AND DIRECTOR MARTIN SAID NO. THE MOTION CARRIES 3/2.

PRESIDENT ALLEN ASKED IF THERE WERE ANY OTHER RELEVANT QUESTIONS? A QUESTION FROM THE FLOOR: WHERE WILL THE NEW BALLOTS BE MAILED BACK TO? ANSWERED: THAT WILL BE DETERMINED BY THE BOARD AT A LATER DATE. ANOTHER QUESTION FROM THE FLOOR: WAS THE BOARD NOTIFIED OF THIS COURT DATE FOR THIS MORNING? ANSWERED: NOT OFFICIALLY, WE RECEIVED AN EMAIL FROM MICHELLE MORGANTI, BUT NOT AN OFFICIAL NOTICE FROM THE COURT.

DIRECTOR LOLLAR STATES THAT A WRIT HAS BEEN SERVED AND THERE IS A NEED TO SEAL THE BALLOT BOX. DIRECTOR LOLLAR MAKES A MOTION TO HAVE THE BALLOT BOX SEALED AND DIRECTOR DALEY SECONDED THE MOTION. THE ROOM ERUPTED WITH A LOT OF LOUD TALKING AND SCREAMING.

PRESIDENT ALLEN CALLED FOR A 10 MINUTE RECESS AT 2:35 PM AND REQUESTED THAT THE BOARD MEMBERS JOIN HIM IN THE NEXT ROOM.

PRESIDENT ALLEN RESUMED THE MEETING AT 2:50 AM. THERE IS STILL A MOTION ON THE FLOOR. DIRECTOR LOLLAR REPEATS THE MOTION TO SECURE THE BALLOT BOX AND DIRECTOR DALEY SECONDED THE MOTION. PRESIDENT ALLEN CALLS FOR A SHOW OF HANDS TO SIGNIFY AYES. DIRECTOR LOLLAR, DIRECTOR DALEY, AND DIRECTOR MARLOW RAISE HANDS SIGNIFIYING AYES. PRESIDENT ALLEN CALLS FOR A SHOW OF HANDS TO SIGNIFY NO, DIRECTOR MARTIN AND DIRECTOR ALVAREZ RAISE HANDS TO SIGNIFY NO. THE MOTION CARRIES 3/2 TO SECURE THE BALLOT BOX AND NOT DESTROY BALLOTS. A STATEMENT FROM A PROPERTY OWNER FROM THE FLOOR THAT BALLOTS MUST BE MAINTAINED FOR 7 YEARS.

DIRECTOR LOLLAR READS FROM HV OF FORK OWNERS' ASSOCIATION BY-LAWS AMENDED AND RESTATED, JULY 17<sup>TH</sup>, 2022, ARTICLE THREE, BOARD OF DIRECTORS, SECTION 2. "EXCEPT AS OTHERWISE PROVIDED IN SECTION THREE OF THS ARTICLE 3, DIRECTOS SHALL BE ELECTED AT THE ANNUAL MEETING OFMEMBERS AND SHALL SERVE A TERM OF THREE (3) YEARS AND THEREAFTER UNTIL THEIR SUCCESSORS ARE ELECTED AND HAVE QUALIFIED. ANY DIRECTOR MAY SUCCED HIMSELF/HERSELF AND SERVE AS MANY CONSECUTIVE TERMS OR NON-CONSECUTIVE TERMS AS HE/SHE MAY BE ELECTED. DIRECTORS MUST BE MEMBERS OF THE ASSOCIATION.

MORE LOUD SHOUTING AND DISCOURSE FROM THE FLOOR. DIRECTOR LOLLAR MAKES A MOTION TO ADJOURN AND DIRECTOR DALEY SECONDED THE MOTION TO ADJOURN, PRESIDENT ALLEN ASKED FOR DIRECTORS TO SIGNIFIY WITH AYES TO ADJOURN, 3 AYES FROM DIRECTOR LOLLAR, DIRECTOR DALEY, AND DIRECTOR MARLOW.
