PRESIDENT ALLEN LED GHE INVOATION AND OPENED THE MEETING AT 1:00 PM. PRESIDENT ALLEN ASKED FOR A MOTION TO ACCEPT THE PREVIOUS MINUTES AS POSTED TO THE WEBSITE. DIRECTOR LOLLAR MAKES A MOTION TO ACCEPT THE MINUTES AS POSTED AND DIRECTOR MARLOW SECONDED THE MOTION. ALL IN FAVOR, AYES CARRY, NONE OPPOSED AND THE MOTION CARRIES.

PRESIDENT ALLEN ANNOUNCES THAT AN ELECTRONIC VOTE OF THE BOARD OF DIRECTORS OCCURRED SINCE THE LAST OPEN MEETING. PRESIDENT ALLEN READ THE ELECTRONIC VOTES ON THE SUBJECT OF A VARIANCE FOR THE BECKETT PROPERTY. PRESIDENT ALLEN MAKES MENTION THAT DIRECTOR ALVAREZ WAS PART OF THE SALE OF THE PROPERTY BUT WAS NO LONGER THE REALTOR AT THE TIME OF THE FINAL SALE. THE ELECTRONIC VOTE IS AS FOLLOWS:

DIRECTOR MARTIN VOTE IS NO TO VARIANCE.

DIRECTOR ALVAREZ VOTE IS YES TO VARIANCE, AND SHE WANT THE DECISION TO BE MADE AND VOTED ON BY THE ENTIRE MEMBERSHIP.

THE FINAL ELECTRONIC VOTE IS 4/1 TO NOT ALLOW THE VARIANCE.

PRESIDENT ALLEN ANNOUNCED THAT HE CALLED THIS EMERGENCY MEETING BECAUSE A REPORT WAS MADE BY A PROPERTY OWNER THAT SHE WAS TOLD THAT \$190, 000 IS MISSING FROM THE POA FUNDS. PRESIDENT ALLEN ANNOUNCED THAT HE WOULD LIKE TO READ A PREPARED STATEMENT: THE STATEMENT READ ALOUD AS FOLLOWS:

"I CALLED THIS EMERGENCY MEETING SATURDAY MORNING WHEN THE MATTER CONCERNING A REPORTED \$190,000 MISSING FROM HV POA ACCOUNTS. I CALLED THE INDIVIDUAL THAT REPORTED THE ISSUE TO VERIFY THE REPORT OF THE FINANCIAL BREACH. ELIZABETH UPCHURCH STATED THAT BRANDI MARTIN APPROACHED HER (ELIZABETH) AFTER THE CANDIDATE'S FORUM THURSDAY APRIL 11, 2024 AND ASKED ELIZABETH TO POST ON ELIZABETH'S SITE THAT \$190,000 DOLLARS WAS MISSING FROM THE POA FUNDS. ELZIABETH TOLD HER TO BRING THE EVIDENCE AND SHE WOULD POST THE ISSUE. IT IS THE BOARD OF DIRECTORS, PRESIDENT, TREASURER, MANAGER AND STAFF'S FIDUCIARY RESPONSIBILTY TO REPORT ANY ACCUSATIOPNS OF FINANCIAL DECEIT IMMEDIATELY.

I AM CALLING ON BRANDI MARTIN TO SUBSTANTIATE HER CLAIMS WITH THE EVIDENCE THAT BRANDI MARTIN HAS DISCOVERED AND PRESENT THE EVIDENCE OF FINANCIAL DECEIT TO A THIRD-PARTY FORENSIC AUDIT TEAM IMMEDIATELY. THIS THIRD-PARTY AUDIT TEAM SHOULD BE HIRED BY THE POA TO ASSURE COMPLETE TRANSPARANCY IN FINDING THIS ACCOUNTING BREACH.

DECEIT, EMBELZEMENT, COOKING THE BOOKS ARE SERIOUS ALLEGATIONS IMPUNING THE INTEGRITY OF EVERY BOARD MEMBER, PRESIDENT, TREASURER, MANAGER AND OFFICE STAFF PAST AND PRESENT. IT IS IMPERATIVE THAT THE INNOCENT PEOPLE DOING THE BUSINESS OF HOLIDAY VILLAGE LAKE FORK HAVE THEIR NAMES CLEARED IMMEDIATELY. THE THIRD-PARTY FORENSIC AUDIT TEAM WILL CLEAR THE INNOCENT AND FIND THE GUILTY. IF BRANDI MARTIN'S ALLEGATIONS ARE FOUND TO BE TRUE BY THE THIRD-PARTY AUDIT TEAM OF THE ISSUE OF \$190,000 DOLLARS MISSING FROM HOLIDAY VILLAGE POA FUNDS, I RECOMMEND THE BOARD OF DIRECTORS PURSUE PROSECUTION TO THE FULL EXTENT OF THE LAW. ASSOCIATION BOARD MEMBERS MUST STOP MISINFORMATION BY COMMUNICATING THE CORRECT INFORMATION IMMEDIATELY. A LACK OF RESPONSE REFLECTS APATHY POINTING DIRECTLY TO THE BOARD, PRESIDENT, TREASURER, AND STAFF. FROM GM AMMONS: ON APRIL 12<sup>TH</sup> 2024 AT 6:40 PM "MR. PRESIDENT, I AM REQUESTING AN EMERGENCY EXECUTIVE SESSION AT THE EARLIEST POSSIBLE DATE. I AM ASKING THAT BRANDI MARTIN WIFE OF DIRECTOR RICHARD MARTIN BE INVITED TO ATTEND AND PRESENT HER EVIDENCE OF "MISSING MONEY". THIS KIND OF RUMOR NEEDS TO BE CHALLENGED AND ANSWERED. MY STAFF IS VERY ACCOUNTABLE AND ALL MONIES CAN BE TRACKED AND ACCOUNTED FOR. FOR THIS TO COME FROM A DIRECTORS HOUSEHOLD IS A REAL BREACH OF FIDUCIARY RESPONSIBILITY OF THE DIRECTOR FOR NOT BRINGING SUCH A CLAIM FORWARD IMMEDIATELY. I AWAIT YOUR RESPONSE." JOE

GM AMMONS: ON APRIL 12<sup>TH</sup> 2024 6:45 PM"WE ONLY HAVE TO GIVE A 72 HOUR NOTICE."

DIRECTOR ALVAREZ: APRIL 12, 2024 9:16 PM" THIS MISUSE OF EXECUTIVE SESSIONS FOR ADDRESSING RUMORS IS INAPPROPRIATE. EXECUTIVE SESSIONS SHOULD BE RESERVED FOR MATTERS THAT GENUINELY REQUIRE PROVACY, NOT FOR ADDRESSING EVERY RUMOR THAT ARISES. IF WE USED THEM FOR THIS PURPOSE, WE WOULD BE IN EXECUTIVE SESSION CONSTANTLY. THANK YOU BRANNON."

ELIZABETH UPCHURCH MAKES A STATEMENT THAT SHE WAS TOLD BY BRANDI MARTIN THAT THEY DISCOVERED \$190,000 WAS MISSING FROM THE POA. MICHELLE MORGANTI MAKES A STATEMENT THAT ITS ALL LIES.

PRESIDENT ALLEN STATES THAT IT IS THE BOARDS BUSINESS, THEY NEED TO MAKE A DECISION ON WETHER OR NOT TO DO AN AUDIT.

(IT IS NOTED THAT THERE IS A LOT OF SCREAMING BETWEEN THE TWO LADIES FROM THE FLOOR)

PRESIDENT ALLEN CALLS FOR A 5 MINUTE RECESS AT 1:30 PM.

PRESIDENT ALLEN CALLS THE MEETING BACK TO ORDER AT 1:40 PM.

DIRECTOR LOLLAR MAKES A STATEMENT, "NONE OF US FEEL THAT THERE ARE ANY MONIES MISSING."

ELIZABETH UPCHURCH STATES THAT SHE WILL PAY FOR AND HAVE A LIE DETECTOR TEST DONE IF BRANDI WILL DO THE SAME AND PAY FOR HERS.

GMA AMMONS ASKED, "WHAT DID I LIE ABOUT?" DIRECTOR MARTIN ANSWERED, "JOE YOU SAID IT WAS GROUND POUNDERS THAT LIED." GM AMMONS MAKES A CALL TO GROUND POUNDERS OWNER, LOGAN AND PUTS HIM ON SPEAKER. PRESIDENT ALLEN RECEIVED A PHONE CALL FROM DIRECTOR LOLLAR THAT WE NEEDED TO SCHEDULE A MEETING, AND HE LATER CALLED ELIZABETH UPCHURCH TO VERIFY HER REPORT.
