Old Business:

The Collection policy reads that when an account exceeds \$750.00 in arrears, the POA will file a lien unless the property owner is making a good faith effort to pay. If we file a lien and that lien is on the court docket then that information becomes public and the POA will make this public at the clubhouse for all members to view. The POA will file up to 10 liens per month. Director Ammons motions to accept policy, Director Roach seconded motion, all in favor, none opposed, Ayes carried and the motion passes.

Director Ammons states that the Board is currently meeting monthly, but would like to propose that it be changed to quarterly meetings. Director Wilder makes motion, Director Roach seconded, all in favor, none opposed, Ayes carried and the motion passes. The Board will meet on August 21, 2021 and then go to quarterly meetings.

President Houston calls for the Treasurer's Report. Treasurer Picou begins by reading the bank balances from last year and then current balances. Total income for June \$79,744. Expenses of \$86,118. This is a positive negative due to rentals and purchase of vehicle and culvert installation and gate repair. Bills were all paid. Monies still coming in from the Developer for projects.
